The meeting was called to order by Chairman Berres at 5:00 p.m.

Members present: Ed Benter, Jeff Berres, Cathy Houchin, and Dennis R. Schmidt.

Member(s) absent: Ed Nelson.

Others present: Patti K. Hilker, Treasurer, John F. Corey, Corporation Counsel, Michael Sterr, and an unidentified adult male member of the general public.

A motion was made by Schmidt, and seconded by Benter to approve the agenda and to allow the Chairman to go out of order as needed to efficiently conduct the meeting. Motion carried.

A motion was made by Schmidt, and seconded by Benter to approve the May 19, 2016 minutes as presented. Motion carried.

The Committee considered and discussed a parcel of real estate to which Dodge County Parcel Identification Number 006-1215-1641-025 has been assigned, located in the Town of Burnett, formerly owned by Larry DeVries, and now owned by Dodge County.

The Committee opened bids on unsold 2016 In Rem properties and accepted and rejected bids.

PIN 022-1116-1522-001: One closed bid was received for this parcel of real estate located in the Town of Hubbard.

The first bid opened was from Clayton Klink, in the amount of \$150. Enclosed with the bid is a completed bid form and a cashier's check in the amount of \$150, made payable to the Dodge County Treasurer.

A motion was made by Schmidt, and seconded by Benter to accept the bid in the amount of \$150 submitted by Clayton Klink for the purchase of the parcel of real estate to which Dodge County Parcel Identification Number 022-1116-1522-001 has been assigned. Motion carried.

A motion was made by Houchin, and seconded by Benter to not reestablish an appraised value for a parcel of real estate to which Dodge County Parcel Identification Number 236-1116-0632-100 has been assigned, located in the City of Horicon. Motion carried.

A motion was made by Schmidt, and seconded by Berres to authorize and direct the County Treasurer to advertise unsold In Rem properties for sale. Motion carried.


John F. Corey and Patti K. Hilker gave oral reports regarding the status of the 2016 In Rem Foreclosure properties.
