A motion was made by Benter, and seconded by Nelson to approve the agenda and to allow the Chairman to go out of order as needed to efficiently conduct the meeting. Motion carried.

A motion was made by Nelson, and seconded by Benter to approve the March 31, 2017 minutes as presented. Motion carried.

The Committee considered and discussed Lots 3, 4, 5, 7, and 8 of the Plat of Monarch Development, located in the City of Beaver Dam, Wisconsin.

A motion was made by Houchin, and seconded by Benter to reestablish an appraised value for the unsold In Rem property identified as Parcel Identification Number 206-1214-3333-121, in the amount of \$3,000. Motion carried.


A motion was made by Houchin, and seconded by Nelson to authorize and direct the County Treasurer to advertise unsold In Rem properties for sale. Motion carried.
