Hoffman: Shared that he is working with UWEX Administration on a preliminary budget number for Extension staff in 2018. In addition, he lead a discussion about providing information to Committee members to help them better understand the totality of Dodge County educational programming. He will provide a draft document for members to review by June 13th.

Witzel: Witzel reported on the successful Dairy Brunch held on June 4. It was one of the largest in years with many interactive displays for visitors. We also had a lot of state representatives and dignataries attending. We are busy with camp planning for the Summer camp and also the Wild Wacky Weekdays. Dodge County is hosting Area Animal Science Days on Friday if committee members are interested in attending.

Carroll: Carroll reported that she has been working with several parents because of court mandated parenting education. Carroll reported that Family Court has been referring parents more frequently. Carroll also reported that she continues to work with The Greater Watertown Health Foundation and the new calloborivte "Every Child Thrives". In an effort to not duplicate services, Carroll is orchestrating a merging of Dodge CARES and the new collabortive. Carroll also reported that she helped write a \$40,000 grant for The Gathering Source.

Young: Young discussed the completion of this years tractor saftey class with the colncosion of the driving test. She also talked about the great turnout at this years Farm City Day, and her role and talking with the youth about animal genetics. Young additionally meet with multiple farms this month helping to address a vairity of different concerns.

Ortiz-Ribbing: Addressing current season's planting issues and winter damage to alfalfa and wheat. With the assistance of the Forage Council members, alfalfa PEAQ readings are being collected and posted to and shared through. UWEX websites and Facebook. Interseeding trial with cover crops in corn established on the farm of Marty Weiss. Facilitating Farmer Led group's June 8th meeting with Foremost, DBA, and The Nature Conservancy. Data from 213 Dodge and Fond du Lac Agricultural Needs Assessment Surveys (paper and online), conducted by Amanda Young and myself, has been entered and proofed. Analysis is in progress

Lafler: Lafler reported making contacts and scheduling dates for Nutrition education with partnerships at local food pantries, Green Valley Enterprises and Forward Service. Working on lesson plans and education materials for the summer partnerships.

Richardson:


