

**DODGE COUNTY PLANNING, DEVELOPMENT AND PARKS COMMITTEE
MINUTES
August 21, 2017**

The Dodge County Planning, Development and Parks Committee met on August 21, 2017 at 7:00 p.m. on the 1st Floor of the Administration Building, Juneau, Wisconsin.

Chairman Schaefer called the meeting to order. Roll Call was taken. Members present were Tom Schaefer, Allen Behl and Janice Bobholz. Members excused were William Muche and Joseph Marsik. The staff present at the request of the Chairman was Joseph Giebel. Bill Ehlenbeck and Nate Olson were also present to present information to the Committee.

The Chairman asked the staff to confirm compliance with the open meeting laws and the public hearing notice requirements. Mr. Giebel noted that the meeting was properly noticed in accord with the open meeting law and noted that the required notice for the public hearing listed on the agenda was posted, mailed and published in accord with the statute and code requirements.

The agenda was reviewed.

3. Discuss proposal to create County information videos for County website.

Nate Olson provided the Committee with information on a potential online marketing tool for the County. CGI Communications, Inc. is a marketing and advertising company that works with Wisconsin communities to develop informational videos to promote the community. The information video's would be linked to the County's website and would be used to provide information such as: An introduction to the County, economic development, park/recreation, tourism, nonprofit organizations, etc... The company would create 5 videos at no cost for the County which will be integrated into the County website. Sample videos from the Eau Claire County website were viewed by the Committee. Nate indicated that a presentation on the information video will be made to the executive committee at their next meeting to determine if the County is interested in this marketing tool.

The hearing procedures were read into the record.

PUBLIC HEARING

Craig and Kelli Youngbeck agents for Phillip Majerus – Petition to rezone approximately 8.2-acres of land from the A-1 Prime Agricultural Zoning District to the A-2 General Agricultural Zoning District under the Land Use Code, Dodge County, Wisconsin to allow for the creation of a non-farm residential lot on this site. The property is located in part of the NW ¼ of the NE ¼, Section 23, Town of Leroy, the site address being W3099 Lomira Drive.

Motion by Janice Bobholz to submit a favorable recommendation to the County Board on the rezoning petition to rezone approximately 8.2-acres of land from the A-1 Prime Agricultural Zoning District to the A-2 General Agricultural Zoning District under the Land Use Code, Dodge County, Wisconsin to allow for the creation of a non-farm residential lot on this site.

Second by Allen Behl Vote 3-0 Motion carried.

The minutes from the August 7, 2017 meeting were reviewed by the Committee.

Motion by Allen Behl to approve the minutes as written.

Second by Janice Bobholz Vote: 3-0 Motion carried.
