Circuit Court/Judge's Report: None

Clerk of Courts Report: Michelle Kenning reported on the upcoming two (2) week jury trial in Branch 1 where they will be using jurors from Jefferson County.

Child Support Report: Bernie Mueller reported on the new tax guidelines they need to follow with the new requirements. The child support employees will get fingerprinted and have background checks. This policy will go to the HR Department for approval.

District Attorney Report: None

Medical Examiner Report: None

Sheriff's Office Report: Sheriff Schmidt reported that the number of crashes and runoffs were up because of the weather. He sends high praises to the Highway Department for keeping up on the roads during the bad weather.

The Executive Law Enforcement banquet was held with several nominated for awards. Attorney Klomberg made a statement regarding the Citizen of the Year award and the Executive Professional award going to Assistant District Attorney Jim Sempf.

Sheriff Schmidt reported on the numbers of hours he works/logs and in 2018 logged over 400 hours above what a normal exempt employee is expected to work. Question by Dan Hilbert as to the hours worked by exempt employees.

The consideration to abolish the detective position needs more time for review. It will be held over to next month. A comment made by Joe Marsik regarding the Sheriff's Office moving around Detectives to Sergeants.

Dan Hilbert asked to hear more on the status of the drug task force.

Chief Deputy Scott Mittelstadt gave a presentation on the Leadership in Police Organizations Training. He is a certified trainer for the program. He indicated that this program focuses on the behavioral science approach to leadership. This is a three (3) week program and he goes over the topics to be discussed each day for each week. He touched on the hours that he puts in at the Sheriff's Office.

Statement by Dustin Beck on the positive effects the program had on him with this new position.

Statement by Jeff Berres as to the funds used for this training. Response by Sheriff Schmidt.

Kim Nass commented as to how many participated in this training (10 people participated at the class held in Dodge County).

Deputy Mittelstadt indicated that Dodge County will host the training again next year. Donna Maly questioned how he was updated on the new material/issues.

A/V Project Report: Mielke reported that the AV project is on track. The project was publically noticed. The bids are due March 20, with a walk through scheduled for March 1.

Operational Review of Sheriff's Office: Mielke deferred to Kim Nass. She said they will provide a status report for the Executive Committee on March 5, 2019. She indicated that Mr. Brady will put together a survey for the employees to submit. He will report on the progress. The final report is due by the August County Board meeting.

Informational Presentation: Shelby Brandsma from Family Court Services. She said they changed their name from Family Court Counseling to Family Court Services. Their office conducts mediations; custody study evaluations; reports for step-parent adoptions; intake for the Child Support Agency. They have approximately 300 referrals each year. They work for the Judges, not the families. They do home visits; did 58 studies last year; 8 trials; 12 reports were written. They hold a parent education class; also a community outreach with the schools to assist with families on understanding the process.


