5. Application for 2019 BJA Adult Drug Court Discretionary Enhancement grant has been submitted. Awards will be announced on September 30, 2019. The application included funds for a process evaluation conducted by UW-Whitewater to identify areas in the program which need improvement, to increase capacity of DTC by 15 participants, one case management position, and additional funds for monitoring, treatment, drug testing, and to
